I deeply regret those decisions and feel I am deserving of a second chance to reclaim my life. There are no excuses for the selfish decisions I made to engage in the crimes I did, and I make none. Since my incarceration I have had the opportunity to look at my life and the choices I made and there is no doubt that I am no longer that person. I have family that I love and care for and am dedicated to never making those choices that I made long ago, ever again. I have tremendous respect for the law and my freedom and will do nothing to ever jeopardize that again. I would like to shed light on my personal transformation journey that began 15 years ago when I made up my mind to do all I can to become a better human being and show God, myself, my family and others that I can be the leader and positive role model that so many believe I can be. The documents contained in this package not only highlight my qualities but also supports the facts that I am deserving of a second chance. As a first time offender with no prior criminal history it is my sincere hope that my transformation and redeeming qualities will serve as testimony of who I have become along with my desire and commitment to serve my community, especially the troubled youth. I have a strong desire to help these young people make good choices and live happy and healthy lives. I humbly ask that you find it within your heart to grant me clemency so that I may use my God given talents to be a servant leader for my family, my home, my community and the people of Hawaii. As people mature with age, recidivism decreases and I will not let you down Mr. President, as I will only make good solid choices and be the role model and mentor within my community, that I should have been long ago. Please review the attached supporting documents with care, and it is my prayer that you will find me worthy of the second chance to reclaim my life and grant my clemency request. I have endeavored to right the wrong and change my life around by participating in numerous rehabilitative & reintegration programs, and by serving as a positive role model & mentor to thousands of fellow inmates in need of guidance and mentor ship. Since day one of my incarceration, I have made it a point to serve as a positive Role Model & Mentor to thousands of fellow inmates in need of guidance and mentorship.

Since day one of my incarceration, I have made it a point to be a better Father, Son, Spouse, Brother, and Friend and above all, have strived to become a productive member of society and the best human being I can possibly be.

As a first-time offender, I pray for a second chance to utilize my talents and redeeming qualities and promise to turn this tragedy into something positive.

I may not be able to bring back the lives of those who were lost, but my story will go a long way toward helping to save the lives of others and empowering today's at-risk youth to stay on the right path.

It should be noted my Acts of Heroism on three different occasions that prevented the death of a female corrections officer and her unborn baby; and saved the lives of 4 Hawaii County Police Officers and their family members, not to mention the lives of numerous Hawaii County Police Officers who were being targeted in a mass murder suicide plot. All this information can be found attached to this clemency package. For these acts alone I would humbly request that my sentence be reduced from a LIFE sentence, to one more suitable. This is my humble request.

I have completed more than 2500 hours of programming & rehabilitative programs and have
earned hundreds of program certificates, including safety certificates as I was a recycling
specialist for two years. I put in more than 2000 hours in the Safety Department. Petitioner has
volunteered thousands of hours as a tutor, role model, mentor and motivational speaker and is
currently a volunteer at the Williamsburg "suicide watch" program where I mentor and shadow
inmates contemplating suicide. It is also worth noting that I am currently enrolled in the
"Building Trades & Construction Management" course offered as a pilot program by
Williamsburg Tech University and am proud to announce that I am one of five inmates that will
soon be graduating from the program in December 2023! Lastly, I was recently hired by the
recreation department as the new "Sports Commissioner" overseeing all sporting activities on
the entire prison complex and I look forward to improving and implementing new sports
programs that will help ensure a better quality of life for the inmate population.

Upon release, I will be living on the Big Island of Hawaii at my mother's home located at
306 Todd Avenue, in a small tight knit Native-Hawaiian Homestead community of Keaukaha.
I will be caring for my 92 year old mother who lives alone and is in need of assistance.
To help with monthly bills, etc., I will be employed full time as an Assistant Manager at
Palekana Permits, handling and expediting building & planning permits within the county of
Hawaii. I also have two other offers for employment with Iron Workers Stabilization Fund as
as well as iSave Energy Solutions. So there will be no issue with securing gainful employment
as well as medical insurance. (See offers for employment attached.)
I also plan and make a priority to be involved in every aspect of my children's lives and even
though all four of them have reached adulthood since my time away, I will do everything as a
parent to support them in their quest to reach their career goals.
Lastly, I will be volunteering as a youth basketball coach at the community gym and have
aiready made arrangements with several non profit groups to fulfill my calling as a mentor and
role model for at risk children looking for positive guidance and inspiration in their lives.

Aloha President Biden,

First and foremost, I would like to say "Mahalo" (Thank You) for taking the time to read this letter and review my application for clemency. Sir, you are truly a great American! Your legacy will forever be etched in history as the president who brought our country together during a critical and divisive period of hardship and despair.

Today, I salute you and commend you for restoring hope and morale among our American citizens, and, more importantly, for protecting our country's founding principles of Freedom and Equality, which my father bravely sacrificed his life for as a veteran and hero of the Korean War.

My name is Ethan Motta, and I am a native Hawaiian inmate currently serving two concurrent life sentences at F.C.I. Williamsburg in Salters, South Carolina. As a first-time offender, I humbly and respectfully submit this letter seeking your grace and benevolence in commuting my sentence from life to 20 years. It is my hope and prayer that the redeeming qualities I have exemplified over the years, along with the hard work and sacrifice I have made to rehabilitate myself, will be enough to convince you that I am truly deserving of a second chance.

Since my incarceration in 2006, I have made a conscious effort to turn my life around and become the leader many believed I could be. Over the past 17 years, I have completed thousands of hours of programming and rehabilitation courses and earned hundreds of certificates from various institutions (see Clemency Packet). In the last two years, working as a safety orderly in charge of Williamsburg's safety recycling program, I have accumulated more than 2,500 recycling hours and completed numerous safety certification courses required by the safety department (see Clemency Packet).

In 2020, during the height of the COVID-19 pandemic, my safety colleagues and I were part of the prison's "COVID cleanup crew" that risked our lives to ensure safety protocols were enforced and living quarters within the designated units infected with the virus were properly cleaned and sanitized. Aside from my work responsibilities, I have found time to serve as a "motivational speaker" for several institution-sponsored events promoting positive change and personal growth. I am also currently involved with Williamsburg's "Suicide Watch" suicide prevention program, volunteering my time to shadow and monitor inmates who are contemplating suicide. Additionally, I recently enrolled in the 2,000-hour apprenticeship program offered by the institution's education staff and look forward to completing the program within a year.

Today, I continue to serve my true calling as a role model and mentor for those inmates looking to get on the right path. I am proud to say that in a few months I will be graduating from "Williamsburg Tech University" with a two-year certificate in "Building Trades and Construction Management" (see Attached Exhibit A).

Mr. President, there is nobody more ready and more prepared than I am to return home as a productive, law-abiding citizen. According to my latest "Recidivism Risk Assessment" report (Pattern Score), you will find that based on my age (54), my education and program status, zero criminal history points as a first-time offender, and no violent offenses committed in 17 years of incarceration, the Bureau of Prisons has classified (scored) me in the "minimum risk" category for re-offending. This classification means I am less likely to return to prison and makes me an excellent candidate for early release (see Attached Exhibit B).

Sir, I am not looking for a "get-out-of-jail-free pass." All I am asking is for you to consider giving me the lower end (20 years) of the 20-27½ year range that the lead prosecutor, the U.S. Attorney, and the OCRS agreed to give me in my original plea agreement (see Attached Exhibit C). Upon careful review, you will find that all parties, including my lawyer and myself, signed the original plea agreement in 2008. Unfortunately, on the eve of trial, the plea deal was rejected by my District Court Judge, who claimed she was bound by the sentencing guidelines at the time and could only sentence me to a mandatory minimum term of life without parole.

Interestingly, you will also find that the government was adamant about giving me the agreed-upon 20-27½ year sentence when it subsequently filed a motion on my behalf with the district court, asking the judge to depart from the mandatory life sentence based on several reasons and mitigating factors that warranted a departure (see Exhibit D).

In closing, much has been made about the United States being the place of second chances, the country the entire world looks to for Freedom and Democracy, yet we continue to outnumber all other nations when it comes to incarcerating our citizens. It is my sincere hope that your administration will take a long, hard look at this sad reality and do everything possible to make the changes needed within the justice system to return America to being the land of freedom once again.

Thank you for your time and consideration in this very important matter. I look forward to proving to you that I am truly deserving of a second chance.

I am writing this sincere letter of remorse seeking your forgiveness and hoping the genuine words I share will somehow touch your hearts and bring closure to all who have suffered as a result of my careless actions. It has been 20 years since your respective families were devastated by the horrible news, and I am truly sorry from the bottom of my heart for putting you through this traumatic experience and causing you pain and sorrow. Nobody in your families deserved to go through such an ordeal, and I want you to know that not a day goes by without me thinking of those whom I have hurt, especially the children who had to grow up without a father, the wives who didn't ask to be single-parent widows raising children on their own, and the loving parents who had to bury a son they brought into this world, never expecting to say goodbye before themselves.

If only I could turn back time, there are so many things I would have done differently to prevent this tragedy. But at this point, all I can do is show you the positive changes I've made in my life and the steps I've taken since the incident to right the wrongs I've done and atone for this one mistake. Shortly after my arrest and detainment at the Federal Detention Center in Honolulu, I wasted no time enrolling in the prison's "Victim Impact" and "Anger Management" programs. Within six months, I graduated with certificates from both courses. The impact of these programs was profound, prompting me to re-enroll and eventually assist in facilitating the classes, particularly the "Victim Impact" class where I gained insights into the broader repercussions of my actions on both sides affected by the tragedy.

In the summer of 2009, after graduating from my third victim impact class, I took the initiative to write a heartfelt letter to Ms. Hellen Williams, the widow of Lepo Taliese, expressing my deepest sympathy and apologizing for the pain and suffering I've caused her and her family. To my surprise, Ms. Williams responded with a gracious letter of her own, appreciating my offer to help and thanking me for the gesture of aloha during such a difficult time. A similar letter was intended for Manaima Corpuz, widow of Junior Corpuz, though I was unable to send it due to her incarceration at the time.

Despite losing contact with Ms. Williams over the years, my sincere efforts to reach out to both widows served as a turning point that inspired me to turn my life around. Following my sentencing to life imprisonment without parole, I committed myself to self-improvement and rehabilitation. I've completed over 2500 hours of programming and earned hundreds of certificates. Additionally, I've volunteered more than 2000 hours as a motivational speaker, academic tutor, mentor, and role model. Recently, I graduated from the faith-based "Life Connections Threshold" program and earned a degree in "Building & Construction Trades" from Williamsburg Tech College, one of five inmates to achieve this distinction.

Currently, I am enrolled in my fourth "Victim Impact" class and serve as the prison's new "Sports Commissioner," overseeing recreational activities. I also chair the Warden's "Prison Advisory Council" to enhance prison conditions. While I acknowledge I am not perfect, I have diligently strived to become the best person possible. Based on the positive changes I've made and the qualities I've demonstrated over the past 18 years, I humbly ask for your forgiveness. I seek to finally close this chapter of my life and be granted a second chance to fulfill the potential many believed I could achieve.

It is my sincere hope that you will find it in your hearts to forgive me. I pray for the opportunity to one day make amends and prove that I am truly deserving of a second chance. Thank you for your grace and benevolence. I look forward to making things right with your families.

EXTRAORDINARY CIRCUMSTANCES THAT WARRANT CLEMENCY RELIEF

On December 14th, 2006, I was called upon to intervene in a life & death situation after a riot broke out on the 5th floor of the Federal Detention Center in Honolulu.(Refer To Audio Recordings) During the riot several Corrections Officers were taken hostage, one of which was a pregnant female officer by the name of "Officer Lavetai". (See Attached Affidavits & Reports) At the time of the riot I was housed on the 6th floor when unit Officer "Munoz" approached my cell and asked me for help. "Officer Munoz" mentioned that I was the only inmate that could quash the riot and save the hostages since the main leader behind the riot and kidnapping was an inmate who looked up to and respected me.

At first I rejected his desperate request for help, but later agreed to intervene after I was told "Officer Lavetai" was soon expecting a baby. (See Attached Affidavits & Reports) Without wasting time I quickly reached out to the inmates on the 5th floor through the toilet pipes and in less than 15 minutes I was able to speak to the main culprit of the riot who happened to be a high profile inmate and convicted killer.

The discussion was a bit intense at first as the culprit's mind was set on hurting the Officers and anybody else who tried to intervene. I continued to reason with him and just when it seemed my mediation efforts were about to crumble, I brought up the fact that "Officer Lavetai" was pregnant and moments later I was able to convince him to let her go.

It is worth noting that at the time of my heroic deed I had no reason to use this extraordinary act as a means of getting elemency relief or a sentence reduction, since I was still fighting my case at the pre-trial phase. Let it be known when I put my life on the line to save this mother and child, never once did I think about getting a reward or any type of relief for my good deed and truth be told I did it because it was the right thing to do, the selfless thing to do. It is also worth noting, that years later when I was convicted and sent to a Federal maximum penitentiary, I couldn't raise this issue because any word spreading of me saving a Federal Officer would have resulted in my swift and immediate death.

In 2016, while still serving time at a maximum security penitentiary in Virginia, I was called upon once more to intervene in two emergency life threatening situations involving police officers on the Big Island of Hawaii, who apparently shot two high ranking gang members for no justifiable reason and as a result of these unprovoked shootings, various members of the gang "La Familia" were planning to exact revenge on the officers and the entire Hilo Police force in two separate murder-by-suicide plots.

Although my own life was placed in jeopardy, I quickly reached out to "Clint Kaneko" the leader of "La Familia" and did my best to reason with him to call off the attack on the Hilo Police Officers, Just a few weeks later I was able to once again attempt to intervene in a secret murder-by-suicide plot after learning from officer's in the "Central Intelligence Unit"(CIU) that

several disgruntled gang members from a neighboring island was secretly planning to fly into Hilo and go on a mass-murder shooting spree at the Hilo Police station. Without wasting no time, I quickly reached out to "Clint Kaneko" again to inform him of the plot and as a result the vengeful gang members were stopped on their way to the airport.

As with the incident back in 2006, when I saved the pregnant Corrections Officer, I put my life on the line once again to save these Police Officers because it was the right thing to do, not because I was looking for a reward or seeking relief from my concurrent life sentences and given the opportunity to save another life, I would gladly do it again despite the consequences.

In addition, Petitioner will make it a priority to be involved in every aspect of his children's lives and even though all four of them have reached adulthood since his time away, he will do everything as a parent at this stage to support them in their quest to reach their career goals and ultimately help them achieve their dreams.

Introduction

Your employer has made an investment on your behalf in the form of a relationship between their Company, ProService, and you. Employment Agreement

THIS EMPLOYMENT AGREEMENT ("Agreement") is entered into between	ProService ("ProService") and the	e undersigned Employee

which ProService and the Company have agreed to act as co-employers; as of this Agreement. This Agreement pertains to your co-employment with Pro	such the Company is an intende	d third-party beneficiary

- Employment. Your continued employment is as a co-employee of ProService and the Company. A co-employee is an employee with two employers: the Company, as the worksite employer, and ProService, as a Professional Employer Organization. The co-employment relationship allows ProService to provide certain benefits and services to the Company and its employees. In connection with this co-employment relationship:
 - (a) ProService shall be responsible for the payment and administration of your wages, payroll taxes, specified benefits (including prepaid healthcare for eligible employees), workers' compensation, and temporary disability insurance, and to fulfill these obligations ProService retains such authority over you as required by applicable law.
 - (b) The Company shall be your worksite employer and, in this capacity, shall be responsible for providing a safe worksite environment as well as directing, supervising, disciplining, scheduling, training, and controlling your work.
- 2. At-Will Employment. Unless otherwise provided in a collective bargaining agreement or a duly signed individual employment agreement between you and the Company, your employment relationship can be terminated at any time, with or without cause or prior notice, at your option or the option of the Company and ProService. Except as otherwise stated herein, no agreement contrary to this at-will arrangement is valid unless it is in writing and signed by an authorized representative or President of the Company. Any such agreement (other than a collective bargaining agreement or duly signed individual employment agreement) between you and the Company is not binding on ProService and does not change your at-will employment with ProService. No supervisor or representative of ProService has the authority to make any implied or express agreement contrary to the foregoing. Termination of this Agreement by ProService may not necessarily terminate your employment relationship with the Company absent notice to the contrary.
- 3. Paid Leave Policies and Other Benefits. In the event that the Company maintains policies providing paid leave benefits such as vacation, sick leave, PTO, or severance pay, the Company is responsible for any benefits accrued under such policies during employment at the time of termination. ProService does not provide, and has no policy providing, vacation or other paid leave benefits. To the extent the Company provides other benefits pursuant to policies to which ProService is not a party, the Company is solely responsible for providing the benefits prescribed by those policies.
- 4. Reporting Discrimination and Harassment. ProService and the Company do not tolerate unlawful harassment or discrimination against any employee. If at any time you are subjected to or witness unlawful harassment or discrimination or conduct that violates applicable employment policies prohibiting harassment or discrimination, including but not limited to harassment or discrimination based on race, sex, sexual orientation, pregnancy, age, religion, citizenship, color, veteran status, military status, prohibited retaliation, national origin, ancestry, disability, arrest or court record (except as permitted by Section 378-2.5, Hawaii Revised Statutes), marital status or other legally protected basis, you must immediately contact ProService's Human Resources Department at 1-888-892-8878 to report the matter and obtain assistance.

- Feporting Accidents and Injuries. You must immediately report any work-related injuries or accidents to ProService's Human Resources Department at 1-888-892-8878. Except as otherwise provided by law, your sole remedy for work-related injuries is the remedy provided by ProService's workers' compensation insurance coverage. ProService may require you to submit to immediate post- accident drug/alcohol testing. You authorize the release of any alcohol/drug test results to ProService or any of its agents and to the Company and permit them to examine all records for the purpose of investigation of any workers' compensation claim you are involved in. You acknowledge and agree that (a) the Company pays ProService fees in connection with the co-employment relationship described in this Agreement; and (b) a portion of those fees are used to pay for your workers' compensation coverage for the purpose of the co-employers' sharing the exclusive remedy shield against civil litigation for any work injuries suffered by you under your state's Workers' Compensation Act (Section 386-5, Hawaii Revised Statutes).
- 6. <u>Employee Records</u>. You authorize the Company and ProService to exchange any and all information pertaining to your personnel records. Furthermore, you authorize the Company and ProService to exchange your job-related medical information on a "need to know" basis in accordance with applicable law.
- Arbitration. Because of the delay and expense which results from the use of the federal and state court systems, the Company, ProService and you agree to submit to binding arbitration any claims or controversies concerning your compensation, employment, or termination of employment in connection with the co-employment relationship described in this Agreement (rather than to use such court systems). By way of example only, such claims include claims under federal, state, and local statutory or common law, such as the Age Discrimination in Employment Act, Title VII of the Civil Rights Act of 1964, as amended, the Americans with Disabilities Act, Hawaii's Employment Practices Act, the law of contract and the law of tort. Any such arbitration proceeding shall be administered by Dispute Prevention & Resolution, Inc. ("DPR"), or such other alternative dispute resolution service, administrative agency or organization as the Parties may agree, before a single arbitrator. To the minimum extent necessary, the arbitrator shall have the power to modify the employment arbitration rules of DPR or the mutually agreed-upon alternative dispute resolution service, or to fashion such other relief as may be necessary, to render this agreement to arbitrate enforceable.
- 8. Attorney's Fees. If any Party to this Agreement breaches any of the terms of this Agreement, then that Party shall pay to the non-defaulting Party all of the non-defaulting Party's costs and expenses, including attorney's fees, incurred by that Party in enforcing the terms of this Agreement.
- General. This is the entire agreement between you and ProService with respect to the subjects addressed herein, including but not limited to termination of employment, and this Agreement takes the place of all prior and contemporaneous agreements, representations, and understandings. Should any term or provision of this Agreement, or portion thereof, be declared void or unenforceable it shall be severed and the remainder of this Agreement shall be enforceable. Revisions to this Agreement are not valid unless prepared and agreed to in writing by the President of ProService. For the purpose of this Agreement, ProService means the ProService entity that is servicing the Company.





In light of the new Federal Bureau of Prisons program policy inmates serving life sentences or extensive prison time can now seek a reduction in their sentence based on "Extraordinary" circumstances and exceptional postconviction conduct that reflects positive change, personal growth and rehabilitation.

Motta petition for a 'last Hail Mary'?

A Hilo man serving a life sentence without parole for a violent underworld clash on Oahu over convol of illegal gambling that left two men dead of gunshot wounds and another man critically injured has taken to social media in an attempt to gain his freedom via a pardon from President Barack Obama.

As of midday Saturday, 777 people had signed an online petition at Change.org titled "Clemency Consideration for Malu Motta." The petition, which was posted Sept. 22, is designed to be shared on Facebook.

Ethan Keliihoomalu "Malu" Motta, 47, is incarcerated at the high-security U.S. Penitentiary Lee in Pennington Gap, Va. He was convicted in 2009 on two counts of committing murder in support of criminal racketeering, which carries a mandatory sentence of life without parole, after a monthlong jury trial in U.S. District Court in Honolulu.

He and two other men, Rodney Joseph Jr. and Kevin "Pancho" Gonsalves, shot and killed Lepo Utu Taliese, 44, and Romilius Corpus Jr., 40, during a midday meeting Jan. 7, 2004, between rival underworld factions in the parking lot of the Pali Golf Course. Motta also shot 47-year-old Tinoimalu Sao in the head with a silenced .22-caliber handgun.

Sao survived and testified against Motta and Joseph. Taliese, as he lay mortally wounded on the golf course, also said Motta and Joseph had shot him.

Joseph also received a life sentence, while Gonsalves was sentenced to 27 1/2 years.

Kwai-Chang Publico, a Hilo entertainment promoter and owner of Fearless Hawaiian Enterprises, was one who signed the petition. Publico, who wrote Motta "does more good than bad," said Motta was a friend but he "didn't know that Malu" described in media accounts as a statewide crime boss and murderer.

"He was close with everybody, everybody," Publico said Friday. "He's always done a lot of good and helped a lot of people. I used to think of him as Robin Hood back in the day. We've had very parallel lives. ... We worked in the Naniloa, we did promotions, we had a store in the (Prince Kuhio) Plaza. We had the parallels that way, but I don't know him in the other world."

According to the March 11, 2009, issue of the Honolulu Advertiser, Motta took the witness stand and disputed prosecutors' description of him as a gangster and murderer who told an FBI informant in October 2004 he had a state judge "in his pocket." The informant, Johnaven Monalim, testified Motta also told him he had a friend who might one day be governor and pardon him if he were convicted in state court — an apparent reference to Billy Kenoi, a college friend of Motta's who would

be elected mayor in November 2008, and who spoke briefly at a legal fundraiser for Motta in Hilo in 2004.

Kenoi, whose felony theft trial is scheduled to start Monday, told the Advertiser in May 2008 "everybody knows everybody" on the Big Island.

"We live in a small town and when allegations surface, you don't suddenly act like you don't know the person," he was quoted as saying.

The feds assumed jurisdiction over the cases of Motta, Joseph and Gonsalves after they were already in state court.

Motta admitted on the stand he shot Sao and Taliese, saying he feared for his life. He described himself as a college-educated entrepreneur, former student-body president at the University of Hawaii at Hilo and family man who worked with underprivileged children.

A message on the petition attributed to Motta's "family, friends and loved ones" said Motta "acknowledges his past mistakes and has made positive changes in his life" and seeks to "move forward by using his abilities and talents to make positive changes in our Hawaiian community."

Supporters of Motta left dozens of messages on the petition, all urging he be given a second chance. Most were from the Big Island, but many were from Oahu, the mainland, even overseas.

One signer, Nathanlel Davis of Honolulu, sald Motta "taught me how to be a man" and has "done a lot for his community in Hilo." He described Motta as "a pillar of our community."

Another, Drazen Padovan of Rijeka, Croatia, a former UH-Hilo basketball player who graduated in 2000, recalled Motta as "a good guy ... around campus" who "always helped me and was always a good sport."

"Many years after I left ... I could not believe what happened," Padovan wrote.

A Sept. 28 message from Motta said he was "overwhelmed ... to see the names of those who signed the petition and shared comments, especially those I haven't heard from in years."

"I'm just grateful and extremely blessed to have your unconditional support during these tough times," he wrote.

In addition, Motta filed an appeal in June in the 9th U.S. Circuit Court of Appeals. A previous appeal was denied in 2013.

Publico said he thinks Motta's online petition may be "his last Hail Mary."


"If he can get social media support, it might work," he said.

But there was one particular section of the book...one specific law that really stood out to me and it was the chapter called the "The Law of the Ceiling".

\*In this section the Author waxed eloquent when he expressed how we as human beings place unnecessary limitations upon ourselves that on one hand hinders our personal growth and our ability to get through adversity and on the other prevents us from elevating ourselves to a higher level in order to be successful.

### Bureau Rehabilitation and Values Enhancement (BRAVE)

After a bureau-wide disturbance in 1995, the Bureau asked for the development of a program that would target the first time BOP commitment; 32 years of age or younger; with a sentence of more than 5 years. These inmates were identified by Bureau research as having the greatest difficulty conforming to institution rules. In response, a design was approved and a pilot program to intervene with this group of inmates was implemented. Unlike other residentially-based programs in the Bureau, new, young offenders serving lengthy prison sentences were designated directly to the BRAVE Program.

The BRAVE Program is a six month, specialized Psychology Program designed to meet the needs of young, first time offenders with relatively long sentences. Groups meet Monday thru Friday for 3 hours a day in the morning, and the rest of the day will be dedicated to an institutional job assignment. Group titles include: Orientation to Treatment, Adjustment to Incarceration, Rational Thinking, Criminal Lifestyle, Living with Others, Lifestyle Balance, Drug Education, and Success Strategies.


The mission of the Bureau Responsibility and Values Enhancement (BRAVE) Program is to make a positive difference in the lives of young offenders serving lengthy terms of incarceration, through didactic presentations, discussion groups, and the creation of a supportive therapeutic community which assists offenders in development of prosocial values and the achievement of their highest potential.

Recovery is defined as the gradual building and rebuilding of a new life and results in changes in behavior and self-identity. Recovery is gradual progress which includes:

- Becoming honest and responsible
- Recognizing the need to change
- Eliminating self-defeating behavior and thought patterns
- Changing social identity
- Increasing self-awareness and awareness of others and your environment
- Developing a pro-social value system

The very nature of the community requires a great deal of interaction and sharing of issues take place in a public manner. Participants are expected to share personal information about themselves and their past in front of the community to assist themselves and others in the change process. Participants are also expected to help each other by holding each other accountable for unacceptable behavior in private and in public. Community discussions are viewed as crucial to successful treatment. These community interactions begin the formal treatment day in the form of a Community Meeting. These meetings can be positive, uplifting, intense, confrontational, and challenging.

Peers may at times provide support and encouragement to each other and at other times engage in productive levels of confrontation. In short, we believe that people encourage others to commit crimes, and if so, we can help others get free from criminal behavior and practice pro-social living. The professional staff work closely with inmates in the community to create a positive and caring atmosphere, whereby participants can exert positive influence among each other to make meaningful life changes and build a support program to practice attitudes of change.



# Essay #1 Narrative Essay

#### "The Wrong Side Of The Fence" BY: Ethan "Malu" Motta

When I was growing up in Hawaii I lived right across the street from a huge park that included a football field that was fenced in on all sides. Every day after school the neighborhood kids would rush to the park to see who could walk the entire fence line without falling.

Since I lived only a stone throw away from the park I would get up early in the morning and practice walking the fence for at least an hour before the start of the school day and in no time I was tight-roping the entire fence line with relative ease.

As word spread of this fence walking extraordinnaire (me) kids of all ages would show up to challenge me but the results would be the same day in and day out.

Nobody in my neighborhood both young and old could beat me and before long kids were showing up from nearby towns to compete with me and try to steal my reign as the fence-walking king.

As the years went by my fence-walking skills soured to a whole new level and so did my attitude and confidence and soon I was taunting anyone that dared to challenge me.

Well one day I was on the fence showing off my skills balancing on one leg heckling my competitors when I heard the voice of my older brother "Kalani" echoing through the air: "Malu you better get off that fence and help us mow the lawn and clean the back yard." I remember I turned to him while still balancing on one leg saying "I'm not cleaning nothing...I'm staying out here with my friends and walking the fence until the sun goes down."

Of course my brother wasn't to happy about the dismissive remark and before I could take another step I unexpectedly felt my leg get tripped up from under me and found myself threading air bracing for a hard fall to the ground.

When I looked up after the sudden fall my brother "Kalani" was standing over me looking down in dismay and I'll never forget the words that came out of his mouth. He said "Malu...You better get your priorities straight...You better stop starddling the fence already...It's time you make up your mind what you want to do with your life...It's time you choose which side of the fence you want to becom..Because one day you might just fall on the wrong side."

It's been nearly 45 years since those prophetic words were spoken but it continues to resonate with me to this very day because here I am sitting in Federal Prison with multiple life sentences as a result of making very poor decisions that ultimately landed me on the wrong side of the fence.

During my sentencing proceedings years ago my brother 'Kalani" wrote a letter to my judge asking for grace and compassion in giving me a lenient sentence. In his letter he told the story of his youngest brother (me) and how I would challenge all the neighborhood kids to see who could walk the entire park fence the fastest without falling.

He touched on how other kids would come from other nearby towns to compete with me but none of them could beat me.

My brother went on to talk about how he tripped me off the fence one day because I didn't want to help them clean the yard and warned me that if I didn't get my life together that I would not only fall off the fence but that I would eventually fall on the side I wouldn't want to be on and I would regret it very much.

My brother used the fence-walking analogy as a leson to show the Judge that despite all my talents and skills despite all my academic achievements and my college degree despite my leadership abilities and my redeeming qualities the fact that I lived my life straddling the fence between good and bad right and wrong, it was just a matter of time before the inevitable would happen and I would eventually find myself on the "Wrong Side Of The Fence."

# Essay #2 Reflective Essay

### "Reflecting On My Past And Contemplating My Future" "By: Etnan "Malu" Motta

As the 2024 New Year soon approaches and I sit here reflecting my past and contemplating my future I can't help but look back at the life I've lived and the mistakes I've made along the way and I ask myself "Where did I go wrong."

Indeed it would be highly misleading to suggest that I had a hard upbringing and was not afforded an opportunity to succeed in life but the real truth is my parents were very supportive and made sure that myself and my siblings were provided with a roof over our heads, an abundance of food and clothing and were afforded the best private school education no matter how much the cost.

My beloved mother "Elizabeth Motta" was and still is a devout Seventh-Day-Adventist and as far back as I can remember my siblings and I attended sabbath school and church sermons every Saturday, a religious practice I continue to observe even while incarcerated.

My father "Clifford Motta" was a highly-decorated veteran of the Korean.

War a recipient of the Bronze and Silver medals as well as the "Purple Heart"

medallion for the serious injuries he sustained on the battlefield.

As a result of these injuries my father was given full military benefits as a disabled veteran which in turn allowed me and my siblings to qualify for the "G.I. Bill" that entitled each of us to receive a monthly residual income as long as we attended college. Myself and my siblings took full advantage of this opportunity and immediately after graduating from Hawaiian Mission Academy I enrolled at Pacific Union College in Napa Valley California where I majored in Physical Therapy and minored in pre-med.

In 1990 I returned home to Hawaii and enrolled at the University of Hawaii-Hilo-campus where I joined the prestigious "Hawaiian Leadership Program" under the guidance and tutelage of "Manu Meyer" and "Ed Kanahele."

In 1991 I was selected among a number of applicants to be part of UH-Hilo's "Minority Biomedical Research Section" (MBRS) and was assigned to the "Water Circulation and Pollution Division" where I oversaw the collection and testing of water samples throughout the island to determine the presence of staphylococcus and Fecal Coliform Bacteria.

After what seemed to be a career as a college student I finally graduated in December of 1999 as student-body president with a Bachelors degree in Political Science. 

In January of 2020, my mentor "Karl Waldon" and I were discussing the idea of starting an organization made up of current and former inmates who excelled in motivational speaking and were looking to carry on their roles as inspirational leaders and agents of change for those looking to be empowered and wanting to make a difference in this world. The result of our idea was "EmpowerMentors International LLC., a non-profit entity whose goal is to establish a world wide platform that allows inmates and former inmates the opportunity to use their motivational teaching and speaking skills to inspire and empower others.

As Founders and Visionaries of this great charitable organization, it is our mission to insure that all members are provided with the tools and resources to not only share their inspirational stories, but also be able to serve as charismatic leaders, role models and mentors inside and outside of the prison system. Our overall objective is to set up motivational teaching and speaking programs in every Federal and State prison locally, nationally and globally so members (inmates) can continue to use their teaching and speaking skills when they're released.

In early Warch of 2020, right before the pandemic hit, my mentor and I were sitting in his office having a serious heart-to-heart discussion about starting a program to combat sex trafficking, domestic violence, rape and kidnapping (abductions). The discussion came about after I received a number of troubling emails from family members back home in Hawaii telling me how sex trafficking and abductions have become a major problem in the islands.

While raising the subject I could tell this issue touched a soft spot with my mentor and after a long pause, he broke his silence and told me the horrifying story of how his youngest daughter was recently drugged and abducted from a popular nightclub and eventually raped. With tears in his eyes, overwhelmed with frustration for not being able to control the situation and disgust for not being out there to protect his baby girl, he vowed to put together an organization that focused on protection, prevention and rehabilitation for all those who have fell victim to sex trainicking, rape, domestic vicience, kidnapping, physical, sexual and emotional abuse, as well as other forms of exploitation and asked if I could come up with a name and draft the Bylaws.

Several cays later "Sale-Haven International LLC" was born and in the weeks to follow I was able to complete a detailed craft of the Corporate Bylaws. (See Attached SafeHaven Bylaws) As the Founders of this great charitable organization our overall mission will be to set up "SafeHaven" clinics in every town and city of every state in every country and more importantly have a "SafeHaven" ranch or compound set up in remote strategic areas for safety purposes, where victims can receive proper treatment and therapy and participate in vocational, educational and career oriented programs to help them make the transition back into society and be productive citizens.

ARTICLE ONE: NAME & DESCRIPTION

1.01 Name

The name of this corporation shall be EmpowerMentors International LLC, and the business of the limited liability corporation shall be conducted under EmpowerMentors International or EmpowerMentors Universal.

#### ARTICLE I NAME

#### 1.01 Name

The name of the corporation shall be SaveHaven International LLC. The business or DBA shall be conducted and recognized as "SafeHaven LLC." or "SafeHaven International LLC.

## ARTICLE II PURPOSES & POWERS

#### 2.01 Purpose

SafeHaven International LLC, is currently a State of Hawaii non-profit corporation and shall be in operation exclusively for humanitarian and charitable purposes under Hawaii State non-profit provisions and within the meaning of section 501(c)(3) of the internal revenue code of 1986, once Federal non-profit status is obtained.

SafeHaven International LLC's purpose is to provide immediate emergency response, urgent medical care and a safe protective environment for all victims of rape, domestic violence, kidnapping(abduction) and physical, sexual and emotional abuse on a local, domestic and global level.

Our Safe haven clinics will be strategically located in the various towns and city's of every State in every County and each clinic will consist of a qualified medical staff and trauma team that's ready to render medical aid and emergency treatment, skilled professional therapists who specialize in wellness and rehabilitation, as well as research personnel trained to conduct examinations and log the results of all tests and forensic findings into a local, national and international parabase.

Once the notion or victims are tulity examined and properly treated and all tests have been conducted, the victim or victims

With be intermeded by a qualified specialist who will then determine the undisclosed SafeHaven repeat or compound for which the victim or victims will be placed to continue therapy and rehabilitation as well as participate in vocational, educational and career oriented re-entry programs that will allow for a smooth transition back into society.

### MY FIRST LOVE: PLAYING & MENTORING YOUTH THROUGH SPORTS


Sports was and always will be my first love.
